Colleagues good morning or at least it is as I write.

To those of you who have been on holiday I hope you have had a pleasant and restorative break and to those of you yet to go I hope you have one. As you will no doubt have assumed this is the holiday season for our regular LCG and PRG meetings and these will resume in September.

However there are some important Patient participation notes I wish to bring before you. I have put these in italics below because the wording (with just a couple of my edits to make sense of the transposed English) is directly from emails received or the Websites. These are a chance to make our voices heard on a wider stage so please make use of them.

An important matter that I would like your feedback on is how the re-sited FANS (Fenland anti-coagulant) service is working. As service users will know this is now situated in North Brink surgery and I have received mixed messages from patients on how this is working for them. Please let me know if you or any of your patient contacts have experience ASAP as I have some planned meetings when this will be discussed. I would also like to hear how the Blood sampling service at North Cambs now administered by Peterborough Hospitals NHS Trust is working for you.

Have you or your contacts used the Minor injuries unit at North Cambs? If so please let me know how you got on - was the waiting time reasonable, were you able to be fully treated for your condition? My contact details are as usual at the end.

Next month the final processes of selecting the lead provider for the next five years of Adult social care will be started I and some of my colleagues on the PRG group from other CCG LCG's will be part of the process to ensure the patients voice is heard at all stages. There has been a lot of media speculation on NHS privatisation by the back door however under this and the last government and also by EEC rules Private sector participation in the tender process is mandatory. There are also public sector consortia who have participated in the process so a Private sector provider is not a foregone conclusion. Service users can however take comfort that whoever is chosen will face a rigorous condition that in short means that 20% of their income is "outcomes related" which means they will have to satisfy tests to ensure that service users have had the best possible outcome for their experience of the service provided - whether that was Physiotherapy, District Nursing or any of the myriad other services the contract will be providing.

We will be watching on your behalf and of course listening to anything you want us bring forward plaudits or brickbats!

LCG Local Commissioning Group (in Context referring to the Wisbech LCG responsible for commissioning Clinical services in their Local Area using their local budgets);

PRG — Patient Reference Group (this is attached to the CCG and is composed of Mandated [voting] representatives from the LCG's established to monitor and review CCG policies and decisions from a patient's perspective;

PPG - Patient Participation Group (attached to individual Surgeries these can be on line or physically meeting on a regular basis ).
